Why we need your personal information:
 We ask for your personal information so that we can process your application for homestay accommodation. We also ask for information such as your dietary requirements, medical conditions and flight details so we can work with our homestay providers to prepare for your arrival. Our Housing Officer may contact you if we need more information from you and to help prepare for your arrival.

As part of the application process, we will share key information with potential homestay providers to find you the most suitable accommodation.

How we use your personal data:
 We collect other information about you, such as medical information and emergency contact details to see if we need to make any special arrangements for you. If you are applying through an agent, they will also see the information you provide to us.

How your data is stored:
 All of your information is stored on a secure student database used solely by WE Bridge Academy and we also hold this information within your personal student file, which is also stored securely. If you do not enrol at our academy, we will securely destroy the information we hold about you regarding your homestay application within one calendar month. After this time, you would need to reapply if you require homestay accommodation.

You can request to see the information we hold about you at any time. We will acknowledge your request in writing within 48 hours and provide access to the information within one calendar month from the date the request was received.
